PUBLICATION RULES TOG (A CORUÑA) Issn 1885-527X

TOG invites foreign and Spanish occupational therapists, as well as other related professionals of the occupational therapy world, to send us the results of their daily work and research. The Editorial Committee will solve about the publication, reserving the right of asking the main author for modifications or rejecting the publication. The material sent will not be restored. It is recommended to use ANNEX 3 in order to check all the instructions that will be offered from now on the document. The originals, to be accepted for his publication, must fulfil the requirements that are related below:

- The works have to be unpublished and responsibility of his contents falls to the authors.
- Anonymity of patients or users, whose cases are presented, must be protected and it will be the authors' responsibility to protect the ethical aspects of work, guaranteeing that the exposed cases count with the due informed consent. (Appendix 2).
- The author/s, will have to send a Letter of application of publication and declaration of authorship, authors names, academic degrees and affiliation, address, email and telephone number(s), photography in which appears the author and all the co-authors of the document in JPEG format, indicating whom the correspondence will be directed.

1. FORMAT

The works will be sent by email, in attached file shape, in version similar or higher than *Word 97* preferably.

2. LANGUAGE

TOG journal's language is the Spanish and, as a result, is what will be used for the publication. Nevertheless, also originals in other languages will be accepted. If the complete text of the article were in a different language to the Spanish, the Spanish version will also have to be attached, because it is necessary requirement for its publication.

The summaries of the articles will always have to had version in English and Spanish; this clause does not limit that the authors reserve the right to send in addition their summary in the same language to the article (Galician, French, Portuguese, etc.), if this one is different from the Spanish.

3. LENGTH

The recommended maximum length of the texts is 20 pages Din A4, in white background and without letterhead. The paragraph must have spacing 1.5 (double space between lines) and with **Tahoma** letter type, with a 12 point body.

4. TITLES

The first page must include the title (informative and short) of the work in Spanish and in English, and the author or authors' name, with his/her/their post, job, email and telephone.

Work titles and subtitles will never take punctuation at the end, and will be preceded by a full stop and double spacing. The typography used to the different title levels, will be the following one:

- Article title (bold type, body 14 points): After a blank line, it will be put the author name and surnames (12 point body) and in the following line post, job and email address.
- Titles inside the work: The typographic gradation that will be used according to the hierarchy will be the exposed below:
 - First level: Bold type, 14 point body
 - Second level: Bold type, 12 point body
 - o Third level: Cursive writing (italics), 12 point body

5. SUMMARY AND KEYWORDS

Next, in independent page, and preceding the main text, a summary in Spanish and English must appear, with a length around 150 to 200 words, in which the intention, the used methodology or basic procedures are exposed, the main results and the most important conclusions.

After the summary, three to ten keywords or short sentences, that identify the work content, will be specified in order to facilitate its inclusion in repertories and in national and international biomedical database. To select the keywords in English it is recommended the use of the terms of the Medical Subject Headings (MeSH), which can be consulted in http://www.ncbi.nlm.nih.gov/entrez/query.fcgi?db=mesh; for the keywords in Spanish it is recommended the use of the Descriptors in Health Sciences (DeCS,) of BIREME, which can be consulted in http://decs.bireme.br.

If the adequate terms are not still available, for being recent introduction terms, it is allowed to utilize terms in use.

6. PAGE

The font used for the whole work will be the **Tahoma**, with a 12 point body. All pages (included title's one) must be numbered consecutively and on the bottom right and they will be justified. It will be applied 1.5 spacing to the whole work.

7. TEXT

All the works will be able to include an introduction, which will be concise and will have to indicate clearly the objective that has served as base for the realization of the work and its relevance in occupational therapy. Research works will have to be organized, when it was appropriated in Introduction, Methodology, Results and Discussion and/ or Conclusions, Bibliographic References and Gratitude. Please indicate if there was any financial support or sponsorship.

The paragraph beginning must not have indention and the space between them will be of a blank line. There will be two blank lines between the title of a new epigraph and the previous paragraph.

At the end of the numbering of the titles of the different epigraphs or splits it will not be used full stop.

It will be avoided, as much as possible, the excessive use of abbreviations, which will never be used in titles nor subtitles. In the case of using, initially it is written the full name, followed by the abbreviation in bracket that replaces it.

7.1. Original articles

Researches may be organized following the structure:

- 1. **Introduction:** It presents the central idea of the article, its contextualization, background and aims of the study (in addition, it can include a research question, one or more hypothesis and the justification of the research).
- 2. **Methods:** It should describe the study design and methods to explore the central subject and the reason of their choice.
- 3. **Results:** It shows the most representative results of the used methods. They use to be with statistical information, graphics referring to data, collected speeches, etc. They cannot include critics or judgments.
- 4. **Discussion:** It should be used to emphasize most relevant aspects of the study, placing the results in the context of the current literature.
- 5. **Conclusions:** Reflexions about the aims, answers to the research question and the corroboration of the hypothesis. Sometimes they can propose new future research lines.
- 6. References.
- 7. Acknowledgments.

7.2. Review articles

This section includes narrative reviews, systematic reviews and meta-analysis. For this kind of articles, the following structure is suggested:

- 1. **Background:** Introduction to the research question, where the details of the causes and the incidence of the problem are described.
- 2. Aims: Aims of the investigation, what is going to be proved with the

research?

- 3. **Selection criteria:** Principal elements that are going to be considered for the inclusion of articles (or not) in the study:
 - a. Articles categories.
 - b. Participant samples.
 - c. Type of interventions.
 - d. Results measures.

4. Methods:

- a. **Search strategy:** Details of the completeness of search and relevant information. It should include the names of the used headings, the databases, strategies of search, etc.
- b. **Review methods:** Descriptions of how have been selected the total of results for their inclusion, if their quality was analysed, how was extracted the data, etc.
- 5. **Results:** Description of the studies, how much were found and their characteristics after the prior methodological process, the results they show, if doubts exist according to the conclusions of any of them.
- 6. **Discussion:** Interpretation and evaluation of the results.
- 7. **Conclusions:** In this point is needed to separate implications for the clinical practice and implications for research.
- 8. References.

7.3. Case reports

Case reports show little discussions about a case or case series in clinical practices, creating a point of relevance on the scientific observation as well as teaching.

- 1. **Introduction:** Contextualization about the written case. It uses to highlight the importance of the case in terms of prevalence, gravity, difficulties for the recognition of any aspect, form of presentation, etc.
- 2. **Methods:** Description of the data collection process, the theoretical basis for the intervention plan, etc., enough to display a systematic rigor in this section.
- 3. **Exposition of the case:** It consists in the description of the clinic history, evaluation of the patient, etc. The occupational diagnosis process is described as well as the therapeutic option chosen. All the assessments must be adjusted to a specific model or framework for the methodological coherence. More than one can be combined. Cases with unorganized and inaccurate assessments won't be evaluated.
- 4. **Question for the reader:** The question of the intervention is asked after its exposition.
- 5. **Answer:** It briefly answers the question and develops the intervention plan. It is possible to emphasize the relevance of the case and scientific interest has, to discuss how to proceed with it and contextualization of the election.
- 6. **Conclusion:** Explanations about the case solution and clarifications about debatable aspects.

7. References.

7.4. The camera-view occupation

This section tries to show aspects related to human occupation, health and other factors that link both of them through a photo.

- 1. **Introduction:** Context for the reader about the topic and its relationship with photography, core of the article. Often emphasize the importance of human occupation in terms of health or relationship to other factors.
- 2. **Photography:** It must clearly reflect the subject matter and the relationship with a matter concerning human occupation developed according to the text.
- 3. References.

7.5. Critical reviews

In this section come together critical assessments of relevant scientific articles in the field of occupational therapy, it encourages their dissemination among the group. For this reason, we excluded reviews, opinion articles, editorials and case reports.

The document, regardless of the internal organization shall be composed of initial sheet in the following format:

- a) **Title:** Following the format "Critical review: (Original title)"
- b) **Subtitle:** Reference to the analyzed article following Vancouver reference style.
- c) **Author:** According to publication rules of the journal.
- d) **Abstract and keywords:** According to publication rules of the journal. The following structure for the realization of the critical review is proposed:
 - 1. **Article Summary:** parts and ideas of the original words of the author of the recession (not to copy and / or translate the abstract of the original article).
 - 2. **Discussion:** It should develop the following points.
 - a. Contextualization of the article in the context of the discipline.
 - b. Relevance of the original.
 - c. Contextualization of the article over theory: Quote other works and articles that support or refute the author's analysis.
 - 3. **Lines of development:** It should unfold positives (the author of the original contributions to knowledge, how literature can enrich research or open new researches, etc.) and negative (problems or errors other than the reality or difficult to assume, methodological biases and other relevant material).
 - Rating Review: What can bring the item to the training of each occupational therapist? (It is NOT to indicate the point of view whether liked or not)
 - 5. References.

8. PROTECTING THE RIGHT TO PRIVACY OF PATIENTS

The right to privacy of patients must not be infringed without informed consent. No identifying information should be published in descriptive texts, photographs and medical records, unless the information is essential for scientific purposes and the patient (or their family or guardian) gives written informed consent for publication. In this context, informed consent requires that the patient has had access to the original intended for publication.

Identification information will be omitted if not essential, but not altered or falsified in any case in order to ensure anonymity. Complete anonymity is difficult to achieve and, if in doubt, informed consent must be obtained.

The requirement for informed consent should be included in the instructions sent to authors by journals. The derivation has to be indicated in the published article.

9. ILLUSTRATIONS

Works will be able to contain images, charts, tables and figures. This illustration material must go numbered consecutively with Arabic numerals and must bring a clear title and, if necessary, short and descriptive legend. Each figure will appear in the text, in consecutive order. Present the tables in Word files or Excel files.

Present the figures, illustrations and/ or photographs in files with JPG extension and/ or GIF extension. (With the most possible reduced size or the images and slides make up them to 72 dpi, without exceeding the 15cm wide (120K, 425 pixels.))

10. BIBLIOGRAPHIC REFERENCES

The bibliography will be introduced in the following way:

1. <u>"Mention Order System"</u>, quoting by consecutive numbers, in form of superscript between brackets, and enumerating the references in the same mention order. It will be followed the Vancouver Style and the Requirements of uniformity for the manuscripts sent to biomedical journals and of health sciences by the International Committee for Medical Journal Managers.

11. COPYRIGHT

When the process is finished and the article has programmed its publication, the author will receive the communication of that his/her work has been accepted.
